


Competitive Exams in India A brief insight


Writing the Exam: How to solve the paper ?

GMAT is used as an Aptitude Test for admission into graduate business administration program including MBA, Masters of Accountancy etc.

Competitive Exams for Union Public Service Commission

Civil Services IAS Exam- Civil service, the backbone of the Indian government machinery constitutes all the departments which runs the State administration. A highly competitive and challenging area, it involves a variety of jobs in different departments. Compared to private sector jobs this profession has job security. The prestige and power that comes along with these top-notch jobs is a definite reason for anybody to join this profession. The salary, allowances and facilities like healthcare, housing, conveyance etc. also make it a lucrative profession. The new recruitment process of civil services Exam conducted by UPSC is called CSAT or The Civil Services Aptitude

Combined Defense Services Exams - The "Combined Defense Services" Examination or the CDS Exam is conducted twice a year by the Union Public Service Commission for recruitment into the Indian Military Academy, Officers Training Academy, Naval Academy and Air Force Academy. The Notification for the examination is usually released in the months of October and June and the examination is conducted in February and September respectively. Only unmarried graduates are eligible to write the exam. Successful Candidates are admitted into the respective Academies after an interview conducted by SSB (service selection board).

Medical Services Exam- The "Combined Medical Services" Examination or the CMS Exam is conducted by the Union Public Service Commission for recruitment as Medical Officer in various organizations under the Government of India. The Notification for the examination is usually released in the month of September and examination is conducted in January. Successful Candidates are admitted after an interview conducted by the UPSC for those having qualified the written examination

Indian Engineering Services (IES) are the technical services that meet the technical and managerial functions of the government of India. A combined competitive examination is conducted by the Union Public Service Commission (UPSC); for recruitment to the Indian Engineering Services (IES).

IIT_JEE-General Information

IIT-JEE (Indian Institute of Technology-Joint Entrance Exam) is conducted by IITs. Each year one of the IITs acts as the organizing Institute for the overall operation of JEE, for admissions to the Undergraduate Programmes in various engineering disciplines at the prestigious institutes namely :

- Indian Institute of Technology, Mumbai
- Indian Institute of Technology, New Delhi
- Indian Institute of Technology, Guwahati
- Indian Institute of Technology, Kanpur
- Indian Institute of Technology, Kharagpur
- Indian Institute of Technology, Chennai
- Indian Institute of Technology, Roorkee
- Institute of Technology- Banaras Hindu University, Varanasi
- Indian School of Mines, Dhanbad

Pattern of IIT - JEE has been modified commencing from JEE 2006 onwards. Instead of the 2-part Examination by way of a Screening Test (Objective) and a Main Exam comprising 3 Subjective Papers, one each in Maths, Physics and Chemistry (for those who qualify in the Screening Test), there will be only one Examination, subject-wise, each of a 2-hour duration, in Maths, Physics and Chemistry, WITH OBJECTIVE QUESTIONS ONLY.

Medical Entrance Examination-General Information

The field of medical science & medicine is a sunrise-career option full of challenging opportunities encompassing vast area of Research & Development. Indian doctors are appreciated & revered the world over for their effective, easily accessible precise treatment & diagnosis. This is a recognition of the quality of Medical Education in our country. Moreover we are living in the age of Biotechnology, Genetic Engineering & Bioinformatics. So the scope & range of options in Medical science is enormous.

You have before you B.H.U., AIIMS, JIPMER, AFMC & various state PMT's but PMT has a National appeal, as this entrance examination is conducted exclusively for the 15% Merit Positions for the Medical / Dental colleges of India, as specified in the directive of the Supreme Court. So this examination attracts the �Best young brains.

Some Useful information about PMT:

Eligibility

The candidate should be at least 17 years of age at the time of admission or will complete the age on or before 31-12-2005. To be eligible to appear in competitive entrance examination, candidate must have passed any of the qualifying examinations as mentioned in the Information Bulletin. Provided also that to be eligible for competitive entrance examination the candidate must have passed in the subjects of Physics, Chemistry, Biology and English individually and must have obtained a minimum of 50% marks taken together in Physics, Chemistry and Biology at the qualifying examination. In respect of candidates belonging to Schedule Caste/Scheduled Tribes or Other Backward Classes the marks obtained in Physics, Chemistry and Biology taken together in qualifying examination be 40% instead of 50% for General Candidates. Those who are taking plus two examination in 2005 can also appear for the entrance test provisionally subject to their fulfilling the conditions later.

Students from Andhra Pradesh / J & K are not eligible to appear as both these states had opted out of All India scheme. But the students of these states can claim eligibility by submitting an affidavit in original attested by First class Judicial Magistrate that they are not eligible to compete for MBBS/BDS seats in Andhra Pradesh and J&K, or that they are not domiciled in Andhra Pradesh and J&K.

Educational Qualification:

The Higher / Senior Secondary Examination which is equivalent to 10+2 Higher / Senior Secondary Examination, after a period of 12 years study, the last two years of such study comprising Physics, Chemistry, Biology (with practical tests in these subjects).

The intermediate/pre-degree examination in Science of Indian Universities /Board or other recognised examination body with Physics, Chemistry, Biology.

The Preliminary Examination would consist of one paper containing 200 objective type questions (four options with single correct answer) from Physics, Chemistry and Biology (Botany & Zoology) to be answered on the specially designed machine-gradable sheet using Ball Point Pen only.

The duration of paper would be 3 hours.

Final Examination (Only for those who qualify in the Preliminary Examination).

The Final Examination would consist of two papers each of 2 hours duration. Paper-I would contain questions from Physics and Chemistry and Paper-2 would contain questions from Biology (Botany & Zoology).

The Final Examination will have conventional (non-objective) questions to be answered in the Test Booklet supplied.


